Dear Mr. Umbdenstock:

In December 2009, I asked for an accounting of industry funding that American Hospital Association, Inc. (AHA) receives from pharmaceutical and medical device companies as well as foundations established by these companies or the insurance industry. I appreciate your response, which I have attached to this letter. I write today to follow up on any efforts by your organization to improve transparency and accountability in its relationships with the pharmaceutical and device industries.

As I stated in my previous letter, I started my inquiry, in part, as a result of accounts documenting the lack of transparency in financial relationships between the pharmaceutical industry and nonprofit health and medical organizations. Specifically, I cited the April 2008 article in *The Wall Street Journal*, which reported that industry representatives, including ten major drug companies, had formed a coalition to promote looser restrictions on off-label marketing. The coalition had asked the National Alliance on Mental Illness (NAMI) to speak in favor of this issue.

In response to my concerns in my April 2009 letter to NAMI, NAMI began to voluntarily disclose to the public any amount of funding exceeding \$5,000 that it received from pharmaceutical companies and foundations on its website. Further, NAMI began to provide a brief description of the purpose of the funding on its website. I commend NAMI for its leadership and had hoped that when I reached out to your organization and 32 others, your organization would follow NAMI's example and begin posting similar funding information on AHA's website.

As of the date of this letter, it appears that no additional information regarding your organization's industry funding has been posted on the AHA's website. If AHA is currently

taking steps to enhance the transparency of its financial relationships with the pharmaceutical and device industries, I would appreciate information regarding those steps. If not, please explain why your organization does not support the disclosure of funding it receives from pharmaceutical and device companies.

The Medicare Payment Advisory Commission (MedPAC) recommended in a report to Congress in March 2009 that Congress require that pharmaceutical and device companies report their financial relationships with physician groups, patient organizations, and others. More specifically MedPAC said the following:

Given the potential benefits of public reporting, we recommend that the Congress mandate the reporting of comprehensive information on industry relationships with physicians and other health care entities and that the Secretary post this information on a public searchable website.²

MedPAC then went on to say in Recommendation 5-1 that:

The Congress should require all manufacturers and distributors of drugs, biologicals, medical devices, and medical supplies (and their subsidiaries) to report to the Secretary their financial relationship with:...physician groups and other prescribers...patient organizations; and professional organizations.³

I look forward to working with you and other health and medical organizations to further increase sunshine on financial relationships.

This letter responds to your inquiry regarding the American Hospital Association's (AHA) receipt of funding from pharmaceutical companies, medical device companies, foundations established by these companies, or insurance companies. The AHA was among a number of organizations to receive this request.

The AHA, a section 501(c)(6) trade association, represents approximately 5,000 hospitals, health care systems and other health care organizations, as well as 352 associate members and 37,000 individual members. The AHA's activities are predominately supported by member dues, which represent over half of operating revenue. The AHA's total operating revenue in 2008 was \$131 million.

As described in your letter, the background for this request is a separate inquiry you conducted regarding pharmaceutical company funding for consulting arrangements and continuing medical education (CME), and a concern about the lack of transparency regarding the receipt of funding. The discussion below describes the ways in which AHA makes its sources of funding public.

Attached to this letter is a chart providing information on the amounts of revenue received from pharmaceutical, medical device, and insurance companies, and the purpose of the funding for AHA and its tax-exempt affiliates and taxable subsidiaries; this includes contractual relationships between taxable entities and companies in the named industries.¹

The following are responses to the additional five questions requesting information.

1) Describe the policies for accepting industry funds and whether a company may place restrictions or provide guidance on how the funding is spent.

The AHA's activities are conducted to support achievement of its mission and strategic plan. The AHA exercises ultimate control over how outside funding is spent. An exception is the use of donations and grants that fund award programs and research and education to foster excellence in patient care and improvements in community health and the delivery of care. The industry funding received is predominately for sponsorship opportunities (e.g., meetings, events, special inserts in publications), endorsements of insurance products to assist hospitals in meeting corporate responsibilities, advertising and grants. In some instances, sponsorship opportunities in publications or other communication vehicles related to new or emerging issues are suggested by a company and may, after vetting by the AHA, be accepted. The content and editorial control remains with the AHA; input may be offered by the company.

2) Explain any situations in which restrictions apply to the use of funding.

The Foster G. McGaw Prize and the Quest for Quality Prize are two of the grant-funded programs. Additional donation- or grant-funded programs are highlighted in the chart attached.

The Foster G. McGaw Prize recognizes hospitals that have distinguished themselves through efforts to improve the health and well-being of everyone in their communities. It has been funded by donations from The Baxter International Foundation, Cardinal Health Foundation and the AHA. During the period 2006-2009, the outside funding was the same for each year: \$105,000 from each foundation for prize money to the award recipients and for administrative expenses other than staffing. The AHA contributed \$80,000 each year to administer the prize. Administrative expenses are related to staffing, costs for vetting the potential recipients, including on-site, multi-day visits at four locations; and honoring the winners and finalists, including publicizing their community service efforts as examples for others. More information about these awards is available on our Web site: www.aha.org/aha/news-center/awards.

The Quest for Quality Prize recognizes hospital achievements in pursuing the Institute of Medicine's six quality aims and the development of models and systems that can be used by the hospital field. It is funded by the McKesson Foundation: \$200,000 in 2006, \$225,000 in 2007, and \$300,000 in 2009.

3) Explain any plans to adopt policies to ensure transparency of funding.

Financial support received from the industry is currently publicly disclosed through a variety of means. Funding for an award program is recognized through the naming of the award and/or in all related promotional and recognition materials. Similarly, grant projects acknowledge and recognize the financial support of the funder. Sponsorship is publicly recognized as part of the meeting, event or activity and often in advance promotional or related program materials.

Endorsed products are publicized on the Web site. The AHA is reviewing its practices and will consider those best practices consistent in the field and promoted by organizations such as ASAE and the Association Forum of Chicagoland, and other such professional organizations, with the intent to establish formal policies.

4) Explain policies on disclosure of outside income by top executives and board members.

The AHA's board-approved conflict of interest statement requires that AHA officers, board members and employees uphold the highest standards of ethical behavior. As described below, board members and all employees must make full disclosure of any interest that might result in or be deemed to involve a conflict on their part. This would include an affiliation that constitutes a source of income that might reasonably be deemed to involve a possible conflict of interest. Any disclosure of a potential conflict is reviewed and appropriate action taken.

The following is an excerpt from the policy:

It is the responsibility of AHA governance participants to make full disclosure of any interest which might result in a conflict on their part. The Board of Trustees makes a like requirement of an employee and forbids any material conflict of interest on the part of an employee (including an officer who is also an employee).

5) Provide disclosures of outside income filed by top executives and board members.

The AHA's conflict of interest statement and questionnaire, for board members and top executives, was updated last year to capture the information on governance policies requested in Form 990 Part VI Governance, Management and Disclosure about the types of interests that could "give rise to conflicts." The questionnaire, like Form 990, focuses on "relationships" that could give rise to a conflict. There were no disclosures involving conflicts of interest for the industries at issue.

As the national advocate for hospitals, the American Hospital Association has consistently supported our members as they develop policies and practices towards becoming more accessible to and transparent with their patients and communities. The hospital field has a strong historic commitment to transparency, and we're committed to doing even more to build and strengthen the relationships with our patients and communities.

The AHA follows a similar policy of transparency within our own organization, with our leadership and board, with our hospital membership and with the broader public. We support having policies and practices in place to assure that when AHA engages in relationships with vendors its mission is served and the relationship is transparent to members and others who turn to the AHA for information.
