Dear Mr. Falcone:

On January 6, 2012, at approximately 12:45 p.m., a member of my staff who is investigating the Federal Communication Commission's (FCC) decision to grant a waiver to LightSquared, a company owned by your hedge fund, Harbinger Capital Partners, received a phone call from Mr. Todd Ruelle of Fine Point Technologies. Mr. Ruelle indicated that he "only gets paid if this deal goes through" and that "there will be a call center in the Midwest, possibly in Iowa, if this deal goes through." This statement is of particular concern in light of your e-mail to my staff on October 5, 2011, which read in part, "The last thing I want to do is to make this more political than it already is. It doesn't belong in that arena. However, since we are already there, I believe I can make this into a win for the Senator, Lightsquared and the consumer."¹ Taken together, these two statements implied an invitation to pull punches in my investigation. I won't be a part of that.

My staff immediately told Mr. Ruelle that his comments raised red flags, that my only goal in this inquiry was to gather the facts, and that he should cease any further contact with my office.² Following this conversation, my staff contacted the Senate ethics committee regarding his rejection of Mr. Ruelle's unseemly invitation to discuss a quid pro quo and was advised that it was appropriate to avoid further contact with him.

In the course of his phone call to my staff, Mr. Ruelle indicated that while he had not yet been paid by you or Harbinger Capital Partners, he had been offering you advice regarding LightSquared's negotiations with me and the FCC. Mr. Ruelle stated that he did not appreciate the involvement of lawyers and suggested that you directly ask to meet with me, which you then did.

In addition to this comment, he also told my staff that he had booked you for an appearance on Fox News. A recent FOIA request made public by Citizens for Responsibility

and Ethics in Washington (CREW) yielded an e-mail from Mr. Ruelle to a federal employee forwarding his e-mails to Fox News bookers where he arranged for you to appear on the Fox News Channel. In this e-mail chain, Mr. Ruelle writes to the federal employee, in reference to your appearance in which you rebutted charges of political influence with the Obama administration and the FCC. Mr. Ruelle wrote: "I have arranged to hit back HARD!" After that email, the government employee asked Mr. Reuelle not to contact him in the future.³

The day that Mr. Ruelle contacted my office, January 6, my staff contacted your attorney seeking information on the nature of the relationship between you and Mr. Ruelle. More than two weeks later, despite repeated questions, we have yet to receive a response. Accordingly, please answer the following questions in writing no later than January 30, 2012:

- 1. Does Todd Ruelle have any contractual relationship with you, Harbinger Capital Partners, or Lightsquared? Has he ever had any such contractual relationship? If so, please explain the terms of the agreement in detail and produce copies of all records relating to the agreement.
- 2. Is it true that Mr. Ruelle "gets paid if the deal goes through?" If so, please explain in detail how much he will be paid and by whom.
- 3. Why was Mr. Ruelle involved in arranging for your appearance on Fox News?
- 4. Please describe in detail your communications with Mr. Ruelle regarding LightSquared, Harbinger Capital Partners, or my office and provide all records relating to those communications and any other communications with employees or representatives of Harbinger Capital Partners.

Dear Chris:

I am very pleased to hear from you and I would be glad to meet with Mr. Grassely at his convenience to discuss the issues that he raises. In the meantime, I am happy to forward the critical orders that were issue in 2003 and 2005 by the FCC that allowed the predecessor company to move forward and build a nationwide terrestrial/satellite network that is the discussion today. I am also providing you the financial report to Trimble Navigation along with a letter from the United States GPS council urging the commission to grant the terrestrial/satellite application to the predecessor that we are now attempting to build. Finally, I am taking the liberty of providing a clause from Trimble's 10k in 2004 referencing the "non-gps radio frequency bands" that they are using that has been Lightsquared's property.

"Many of our products use other radio frequency bands, together with the GPS signal, to provide enhanced GPS capabilities, such as real-time kinematic precision. The continuing availability of these non-GPS radio frequencies is essential to provide enhanced GPS products to our precision survey and construction machine controls markets. Any regulatory changes in spectrum allocation or in allowable operating conditions may materially and adversely affect the utility and reliability of our products, which would, in turn, cause a material adverse effect on our operating results. In addition, unwanted emissions from mobile satellite services and other equipment operating in adjacent frequency bands or in-band from licensed and unlicensed devices may materially and adversely affect the utility of our products, which could result in a material adverse effect on our operating results. The FCC continually receives proposals for novel technologies and services, such as ultra-wideband technologies, which may seek to operate in, or across, the radio frequency bands currently used by the GPSSPS and other public safety services. Adverse decisions by the FCC that result in harmful interference to the delivery of the GPS SPS and other radio frequency spectrum also used in our products may materially and adversely affect the utility and reliability of our products, which could result in a material adverse effect on our business and financial condition."

The point being that the 2003 and 2005 orders granted by the FCC gave the company the right to build a nationwide network. The GPS community had more than enough time to address the potential issues they disclosed in their financial statements but chose to ignore them and now want others to "pay for their sins", including the consumer for the retrofitting that needs to be done for the existing devices.

All we are doing is trying to build a network which we believe will give consumers a choice, lower their prices, create jobs and expand network capacity to rural areas. Furthermore, what no one discusses is the world's largest satellite that we have hovering at 24,000 feet than can bring immediate communication to the nation, including rural areas. This satellite, more importantly, could be a valuable asset in disasters situations and possibly be a bridge to a First Responder Network that this country so badly needs. One thing I never expected, however, is to see this develop as a political issue. Needless to say, I am quite alarmed at the direction that it has taken.

In any event, I look forward to the opportunity to meet with Mr. Grassley to put these or any other concerns to rest.
