Dear Inspector General Missal:

In August, I wrote to you about Brandon Ketchum, a veteran of the Marine Corps and Army National Guard, who found himself at a crisis point, believing himself to be a threat to his own safety and sought the assistance of the Iowa City VA Medical Center.¹ He was reportedly denied treatment and took his own life just over 24 hours later. Sadly, I have learned that another Iowa veteran, Curtis Gearhart, also committed suicide after he was reportedly denied care at a VA facility in Iowa. Mr. Gearhart is an Iraq War veteran and served two tours as a combat engineer. News reports indicate that Mr. Gearhart was told to wait five to six weeks for treatment for severe headaches, well beyond the VA's goal of 30 days for medical treatment.²

Working to end the suicide epidemic among our veteran population should be an urgent priority. Accordingly, please conduct a thorough investigation into facts and circumstances surrounding the death of Mr. Gearhart.

Please respond by November 30, 2016, and inform me whether you have decided to open an inquiry into the matter. If not, please explain why not. If an inquiry is opened, I further request that you provide updates on its status, when appropriate.
