Dear Mr. Gery:

In August of 2016, Alexis Williams, a 20-year-old employee at Bristol Court Assisted Living Facility, reportedly recorded an 81-year-old woman and 59-year-old man in a private room having consensual sex.<sup>1</sup> Ms. Williams then posted that video to social media via Snapchat.<sup>2</sup> Ms. Williams is being charged with one count of video voyeurism and one count of video voyeurism dissemination.<sup>3</sup>

This reported behavior, perpetrated against one of the most vulnerable populations in our country, is absolutely abhorrent. In order to obtain a better understanding of Bristol Court Assisted Living Facility's preventive policies, please provide the following:

- 1. A description of all social media policies.
- 2. How such social media policies are currently enforced.
- 3. A description of all screening before the hiring of new employees.
- 4. A description of all supervisory guidelines that govern employee conduct.
- 5. How current policies address the violations which resulted in \$6,500 in fines in 2015.<sup>4</sup>
