4 This Act may be cited as the "Consumer and Fuel5 Retailer Choice Act of 2022".

12	(b) Reid Vapor Pressure Limitation.—Section

17	(2) in paragraph $(4)$ , in the matter preceding
18	subparagraph (A), by inserting "or more" after "10
19	percent"; and
20	(3) in paragraph $(5)(A)$ —
21	(A) by striking "Upon notification, accom-
22	panied by" and inserting "On receipt of a noti-
23	fication that is submitted before January 1,
24	2022, or after the date of enactment of the
