According to this Forbes article, Trump recorded the Pledge of Allegiance at MAL and Kash Patel and Ed Henry were also involved. The profits are routed to an LLC run by Henry, and proceeds are intended for families of incarcerated J6 defendants—but there is apparently a vetting process that excludes families of defendants who assaulted police officers. I asked Ahmed to preserve this last night. I'll talk to Maria/Erin and Julia about doing some follow up here to nail down Trump's role.

#### **Trump Collaborates On Song With Jan. 6 Defendants**

[The Hill](#) reported that former President Trump is collaborating with defendants accused of participating in the Jan. 6, 2021, riot at the Capitol in a new song, titled "Justice for All," which was released on multiple streaming services on Friday. The article said that in the song, Trump is heard reciting the Pledge of Allegiance, following a chorus of inmates detained on charges related to Jan. 6 who sing "The Star-Spangled Banner." The article said that money from the song will be directed to their families. An opinion piece featured in [The Independent](#) commented on the saying that the song is both ridiculous and dangerous. The piece claimed it is dangerous because it was released as a widespread GOP effort to rewrite the history of January 6, and continues to signal Trump's efforts to normalize the January 6th rioters as concerned citizens.
