Dear Administrator Oz:

I write in response to the Centers for Medicare & Medicaid Services' (CMS) April 30, 2025, request for information (RFI) on future star ratings for inpatient psychiatric facilities (IPFs). Would like to commend CMS for issuing the RFI and taking meaningful action in response to the letter that I sent on February 28, 2025. Quality measurement and reporting in inpatient psychiatry has lagged considerably behind other health care sectors and the proposed rule presents the opportunity to reduce this gap. As my previous investigations have shown, individuals with serious mental illness are at high risk for patient safety events during psychiatric hospitalizations, and transparency is a critical step towards holding IPFs accountable for providing high-quality, patient-centered, therapeutic, and safe care. My following comments regarding the RFI reiterate many of the points raised in my February 28 letter.

I have long championed the Care Compare website, as well as pushed CMS to make the website operate as efficiently as possible in order to provide patients and their families with clear, concise and publicly available information about health care facilities.⁶ As I have

previously noted, Care Compare can be difficult to understand and star ratings can help consumers make sense of the myriad of measures contained on the website and distinguish between high and low performing facilities. Star ratings, as they simplify complex information into a single and easily digestible score, put more of a spotlight on poor performing health care facilities than a disparate collection of complicated measures, which can further motivate facilities to make improvements. I support CMS's effort to develop and publish star ratings for IPFs.

However, CMS should take steps to ensure the usefulness, accuracy, and reliability of the existing measures in the IPF quality reporting (IPFQR) program before they are included in the IPF star ratings. CMS should evaluate the usefulness of the existing IPFQR measures by actively requesting information from people affected by serious mental illness and their families regarding which measures they find most meaningful. CMS should prioritize measures that capture patient safety, patient experience, and care outcomes. Further, concerns related to the accuracy and reliability of IPFQR measures have been documented in the past. For example, although dated, a study from 2020 found hundreds of errors in the IPFQR program's restraint and seclusion data. Additionally, like other CMS pay-for-reporting programs, the claims-based measures in the IPFQR (e.g. follow-up after hospitalization, medication continuation) are based solely on claims data from traditional Medicare beneficiaries. As previous estimates have found, because a limited portion of patients hospitalized in IPFs have Medicare these measures may provide an incomplete and unrepresentative assessment of IPF quality.

As I noted in my February 28 letter, there are multiple measurement topics not currently addressed by an IPFQR program measure, but would be valuable in IPF star ratings. ¹² As patients in inpatient psychiatric settings are uniquely vulnerable to harm, the IPF star ratings should include measures related to patient safety events, including physical assaults, sexual assaults, suicides, unexpected deaths, injuries, and elopements (unauthorized departures) that occurred during the course of hospitalization. ¹³ This information is not readily available to consumers. Additionally, due to the extreme vulnerability of children hospitalized in IPFs, CMS should consider separating out measures by age group. ¹⁴ CMS should also consider including a

measure of all-cause mortality following IPF discharge, as such measure may capture post-discharge deaths related to self-inflicted injury or other unnatural causes. ¹⁵ Due to their signals as treatment failures, additional measures of restraint and seclusion use may also be valuable, including measures of physical holds and chemical restraints. ¹⁶

Further, for more than two decades I have pushed for reliable, complete, comparable, and publicly accessible health care facility inspection results. ¹⁷ Similar to nursing homes, facility inspection reports are of particular relevance to IPFs. The IPF star ratings should include inspection information, such as the number and type of complaint inspections, citations, and penalties. The health inspections star rating in the nursing home module of Care Compare serves as a good example of how inspection information can be quantified and consolidated. ¹⁸ CMS should assess how information from inspections could be included in the IPF star ratings.
