Dear Secretary Mayorkas:

On October 30, 2023, I sent Troy A. Miller, Senior Official Performing the Duties of the Commissioner for U.S. Customs and Border Protection (CBP), and Katrina W. Berger, Executive Associate Director for Homeland Security Investigations (HSI), letters with respect to their agencies' efforts to secure our southern border from armed immigrants and drones operated by violent Mexican cartels. My oversight letters are enclosed. As you're aware, CBP and HSI are operational and support component agencies of Department of Homeland Security.¹ CBP and HSI both failed to respond by the November 10, 2023, deadline. Since then, there have been several new reports of armed encounters between CBP agents and armed immigrants and the discovery of Mexican cartel produced improvised explosive devices (IED) along the southern border. Due to the Biden administration's disastrous immigration policies, our southern border is in absolute crisis. DHS's consistent failure of leadership raises alarming concerns for our national security.

On December 4, 2023, it was reported that shootouts between rival Mexican gangs caused a surge of immigrants to cross the border from the town of Sasabe, Mexico into Arizona.² It's reported that Sasabe is prized by Mexican gangs because it's a "jumping off point for migrants hoping to cross illegally into the U.S."³ On December 13, 2023, CBP agents reportedly encountered "several armed men" at the U.S.-Mexico border near Sasabe.⁴ On December 15, 2023, reports provide that ranchers in southern Arizona have been warned of increased cartel violence along the southern border, and one rancher heard gunshots in which they described as a "gun battle" occurring just south of Arivaca, Arizona.⁵

In addition, reports provide that the Mexican military discovered 10 IEDs at the U.S.-Mexico border after CBP agents exchanged gun fire with cartel members near a local ranch.⁶


CBP agents subsequently arrested a man on the U.S. side of the border armed with a “loaded AK-47 rifle, two loaded AK magazines, loose rounds and a handgun.”⁷ According to reports, CBP then issued a memo to its agents warning them to “exercise extreme caution” and “report any possible armed subjects approaching the border with possible explosive devices.”⁸ This new memo comes after reports CBP issued an earlier memo warning agents that Hamas and Hezbollah fighters could soon attempt to enter the U.S. through Mexico.⁹ The American public deserves to know how DHS is securing the U.S. homeland from these obvious national security threats.

The need to secure our southern border is paramount and you have failed to do so. Therefore, I request you immediately and fully respond to my October 30, 2023 letters that your subordinates failed to answer. In addition, provide records and answers to the following no later than February 19, 2024.

1. Provide unredacted copies of both CBP memos referenced above.
2. Describe all steps DHS has taken to ensure CBP and HSI officials respond to my oversight letters from October 30, 2023. If none, explain why you failed to ensure timely and complete responses to Congress.

Dear Mr. Miller:

It's an absolute fact that our southern border is out of control. Report after report shows a vast influx of illegal immigrants crossing the Mexico-U.S. border and increased violence occurring near U.S. border towns.¹ Numerous reports make clear that illegal immigrants have armed themselves with weapons, including suspected cartel members, as they approach and cross the Mexico-U.S. border putting U.S. law enforcement and American lives at risk.² In addition, reports also indicate Mexican cartels have increased their use of unmanned aerial systems (i.e., drones) on both sides of the U.S. and Mexico border.³ These drones are used by the cartels to carry out targeted assassinations and violent attacks by dropping explosives in Mexico, monitor and gain reconnaissance on the movements of U.S. Border Patrol (CBP) agents and other U.S. law enforcement officers, and track the progress of their smugglers illegally crossing into the U.S.⁴ The horrific attacks by Hamas terrorists against the people of Israel and their use of weaponized drones to deploy explosives further highlight the need to secure the U.S. border from

these types of national security threats.⁵ Recent reports warning of the risk that Hamas and Hezbollah fighters could soon attempt to enter the U.S. through Mexico illustrates the immediate necessity to secure our southern border.⁶

In June 2023, Texas law enforcement officers, the National Guard, and CBP agents arrested five suspected members of the Cartel Del Noreste in Texas for illegally crossing into the U.S. while armed with rifles and tactical gear and accompanied by several juveniles.⁷ In August 2023, news reports published images of two suspected cartel members illegally entering the U.S. through the Texas border.⁸ These suspected cartel members were spotted carrying rifles and wearing body armor as they illegally crossed the border, but evaded capture.⁹ About a week later, the suspected cartel members were reportedly apprehended after making another attempt to illegally cross into the U.S. in the same area in Texas.¹⁰ On August 18, 2023, it was reported CBP agents were fired upon while trying to apprehend a group of suspected immigrants attempting to illegally enter the U.S. from California.¹¹ These reports indicate CBP agents heard the gunshots directed towards them and took cover as the group of assailants fled back across the border to Mexico.¹²

Additionally, the Department of Homeland Security's (DHS) Homeland Threat Assessment identified use of drones by Mexican transnational criminal organizations as one of the most pressing threats to the U.S. homeland for 2024.¹³ The DHS report states that these transnational criminal organizations are using smaller, commercially available drones; however, more recently, media outlets have indicated that the cartels are now using modified, more sophisticated drones with greater capabilities, such as thermal imagining and the ability to carry

heavier payloads (e.g., explosives, drugs, contraband).¹⁴ These reports have described the cartels as “arming themselves like rogue militaries” and using drones to carry out targeted assassinations against rivals and to watch over their territory.¹⁵ In August 2023, CBS News reported there were *at least* 260 incidents where criminal organizations used drones to carry and deploy explosives, most likely an underestimate.¹⁶ These reports found that criminal organizations in Mexico have attached C-4 or other types of explosives to drones and drop the payload to assassinate or destroy their targets.¹⁷ The cartels in Mexico are also using these drones to increase their efforts to evade detection at the border to illegally cross into the U.S.¹⁸ According to statements by CBP Chief Patrol Agent Gloria Chavez, in just the Rio Grande Valley area alone, there were “over 10,000 drone incursions” and “25,000 drone detections” in just one year.¹⁹ According to Agent Chavez, the cartels are utilizing these drones to track the positions of border patrol officers to gain intelligence on their movements.²⁰

The influx of armed illegal immigrants and cartel members encountered by U.S. law enforcement and the use of Mexican cartel operated drones operated in U.S. territory illustrate why the current situation on the border is a national security crisis.²¹ These threats put the lives of U.S. law enforcement, American citizens, and the national security of our country at serious risk.²² CBP San Diego Chief Patrol Agent Aaron M. Heitke has said “[W]hen events like this occur, we think of our fallen Border Patrol Agents Bryan Terry, Robert Rosas, and others who have paid the ultimate sacrifice in service to this nation” and these dangerous encounters with armed immigrants and cartels on the border must not be tolerated.²³

The recent heinous attacks by Hamas terrorists, who used arms and explosive-rigged drones against Israeli civilians, underscores the very real risk that could happen at our southern border and against Americans.²⁴ Moreover, recent reports warning of the risk that Hamas and Hezbollah fighters could soon attempt to enter the U.S. through Mexico highlights that the need to immediately secure our southern border is paramount.²⁵

So that Congress may conduct objective and independent oversight concerning CBP encounters with armed migrants at the border and Mexican cartels operating drones with potential explosive payloads in around the southern border, please provide answers to the following no later than November 10, 2023.

1. For each of the last five years, how many armed migrants have been identified at the southern border?
2. Of those identified, how many had ties to
 - a. Transnational criminal organizations;
 - b. Terrorist organizations; and
 - c. Countries outside of the U.S. and Mexico.
 - d. List each organization or country at issue.
3. For each of the last five years, how many encounters have occurred between armed migrants and CBP officers? Of those encounters, provide
 - a. the migrant's country of origin;
 - b. the weapons possessed;
 - c. the armed migrant's suspected criminal or terrorist organization affiliation;
 - d. if an arrest was made;
 - e. if the suspect was prosecuted in the U.S.;
 - f. the disposition of the prosecution, length of the sentence, and if the offender was deported back to their country of origin.
4. For each of the last five years, how many CBP agents have been hurt, injured, or fell in the line of duty after encountering armed migrants?
5. Describe how CBP cooperates with other U.S. law enforcement agencies to trace and connect weapons recovered at the southern border to transnational criminal organizations, terrorist organizations, and countries outside of the U.S. and Mexico.

7. With respect to the data in question six, list the
 - a. Type of drone used;
 - b. How the drone was modified (if applicable);
 - c. Describe how the drone was used;
 - d. The number of drones that carried payloads;
 - e. Describe how those payloads were used; and
 - f. The type of payload.
 - g. Provide all records²⁶ to include photos and video evidence of the drones and explosive devices.
8. For each of the last five years, provide the number of drones controlled by operators within the U.S. on the southwest border that have ties to transnational criminal or terrorist organizations.
9. With respect to the data in question eight, list the
 - a. Type of drone used;
 - b. How the drone was modified (if applicable);
 - c. Describe how the drone was used;
 - d. The number of drones that carried payloads;
 - e. Describe how the payload was used; and
 - f. The type of payload.
 - g. Provide all records to include photos and video evidence of the drones and payloads.
10. What support has CBP provided to the government of Mexico to identify the source of improvised explosive devices and explosive payloads deployed by drones and prevent their use?

In keeping with Executive Order 13526, please segregate all unclassified materials within the classified documents, and provide all unclassified information directly to the committees, and provide a classified addendum to the Office of Senate Security. Although the committees comply with all laws and regulations governing the handling of classified information, they are not bound, absent their prior agreement, by any handling restrictions.

In June 2023, Texas law enforcement officers, the National Guard, and CBP agents arrested five suspected members of the Cartel Del Noreste in Texas for illegally crossing into the U.S. while armed with rifles and tactical gear and accompanied by several juveniles.⁷ In August 2023, news reports published images of two suspected cartel members illegally entering the U.S. through the Texas border.⁸ These suspected cartel members were spotted carrying rifles and wearing body armor as they illegally crossed the border, but evaded capture.⁹ About a week later, the suspected cartel members were reportedly apprehended after making another attempt to illegally cross into the U.S. in the same area in Texas.¹⁰ On August 18, 2023, it was reported CBP agents were fired upon while trying to apprehend a group of suspected immigrants attempting to illegally enter the U.S. from California.¹¹ These reports indicate CBP agents heard the gunshots directed towards them and took cover as the group of assailants fled back across the border to Mexico.¹²

Additionally, the Department of Homeland Security's (DHS) Homeland Threat Assessment identified use of drones by Mexican transnational criminal organizations as one of the most pressing threats to the U.S. homeland for 2024.¹³ The DHS report states that these transnational criminal organizations are using smaller, commercially available drones; however, more recently, media outlets have indicated that the cartels are now using modified, more sophisticated drones with greater capabilities, such as thermal imaging and the ability to carry

heavier payloads (e.g., explosives, drugs, contraband).¹⁴ These reports have described the cartels as “arming themselves like rogue militaries” and using drones to carry out targeted assassinations against rivals and to watch over their territory.¹⁵ In August 2023, CBS News reported there were *at least* 260 incidents where criminal organizations used drones to carry and deploy explosives, most likely an underestimate.¹⁶ These reports found that criminal organizations in Mexico have attached C-4 or other types of explosives to drones and drop the payload to assassinate or destroy their targets.¹⁷ The cartels in Mexico are also using these drones to increase their efforts to evade detection at the border to illegally cross into the U.S.¹⁸ According to statements by CBP Chief Patrol Agent Gloria Chavez, in just the Rio Grande Valley area alone, there were “over 10,000 drone incursions” and “25,000 drone detections” in just one year.¹⁹ According to Agent Chavez, the cartels are utilizing these drones to track the positions of border patrol officers to gain intelligence on their movements.²⁰

The influx of armed illegal immigrants and cartel members encountered by U.S. law enforcement and the use of Mexican cartel operated drones operated in U.S. territory illustrate why the current situation on the border is a national security crisis.²¹ These threats put the lives of U.S. law enforcement, American citizens, and the national security of our country at serious risk.²² CBP San Diego Chief Patrol Agent Aaron M. Heitke has said “[W]hen events like this occur, we think of our fallen Border Patrol Agents Bryan Terry, Robert Rosas, and others who have paid the ultimate sacrifice in service to this nation” and these dangerous encounters with armed immigrants and cartels on the border must not be tolerated.²³

The recent heinous attacks by Hamas terrorists, who used arms and explosive-rigged drones against Israeli civilians, underscores the very real risk that could happen at our southern border and against Americans.²⁴ Moreover, recent reports warning of the risk that Hamas and Hezbollah fighters could soon attempt to enter the U.S. through Mexico highlights that the need to immediately secure our southern border is paramount.²⁵

So that Congress may conduct objective and independent oversight concerning Homeland Security Investigation (HSI) efforts to combat and deter armed migrants at the border and Mexican cartels operating drones with potential explosive payloads in and around the Southern Border, please provide answers to the following no later than November 10, 2023.

1. For each of the last five years, how many weapons, to include firearms, RPGs, grenades, and related weapons, have been recovered at the southern border?
2. Of those weapons recovered, how many have been traced and linked to
 - a. Transnational criminal organizations;
 - b. Terrorist organizations;
 - c. Individuals with ties to terrorist organizations;
 - d. The Government of Mexico and related entities; and
 - e. Countries outside of the U.S. and Mexico.
 - f. Provide all records.²⁶
3. Describe how HSI cooperates with other U.S. law enforcement agencies to trace and connect weapons recovered at the southern border to transnational criminal organizations, terrorist organizations, and countries outside of the U.S. and Mexico.
4. For each of the last five years, provide the number of drones controlled by operators in Mexico that have been detected at the southern border. Of those,
 - a. How many crossed into U.S. territory?
 - b. Did any drone operators have ties to transnational criminal or terrorist organizations?
5. With respect to the data in question four, list the

 - b. How the drone was modified (if applicable);
 - c. Describe how the drone was used;
 - d. The number of drones that carried payloads;
 - e. Describe how the payload was used; and
 - f. The type of payload.
 - g. Provide all records to include photos and video evidence of the drones and payloads.
8. Have terrorist organizations or individuals with links to terrorist organizations advised transnational criminal organizations in Mexico on how to assemble or create improvised explosive devices or similar destructive devices? If so, which organizations? Provide all records.
9. What support has HSI provided to the government of Mexico to identify the sources of improvised explosive devices and explosive payloads deployed by drones and prevent their use?

In keeping with Executive Order 13526, please segregate all unclassified materials within the classified documents, and provide all unclassified information directly to the committees, and provide a classified addendum to the Office of Senate Security. Although the committees comply with all laws and regulations governing the handling of classified information, they are not bound, absent their prior agreement, by any handling restrictions.
