Dear Attorney General Bondi and Director Patel:

On August 6, 2020, as Senator Johnson and I were finishing our September 23, 2020, report on the Biden family's financial connections to foreign governments and questionable foreign nationals, the FBI's Foreign Influence Task Force provided a briefing to us on behalf of the FBI and Intelligence Community. As I have publicly and privately stated to the both of you and your predecessors, the briefing was unnecessary and was only done because of pressure from our Democratic colleagues, including Democratic Leadership, to falsely attack our Biden investigation as advancing Russian disinformation. Those joint FBI-Democratic efforts obstructed my and Senator Johnson's work.

Simply put, the unnecessary FBI briefing provided the Democrats and liberal media the vehicle to spread their false narrative that our work advanced Russian disinformation. Time has shown that the financial records we released in both of our 2020 Biden family reports, and bank records we later made public in 2022 in three speeches from the Senate floor, were exactly on target and not Russian disinformation.<sup>3</sup>

At the briefing as well as after, we requested relevant records relating to what happened at the briefing, including the 302 or similar summary, the intelligence basis for the briefing and the personnel involved in making the decision to brief us. On August 12, 2020; May 3, 2021; July 25, 2022; and August 11, 2022, I made those requests.<sup>4</sup> Prior to your confirmations, the FBI has consistently failed to respond in full to each request and failed to provide those critical records which creates more questions about the true purpose of the briefing.

One of the FBI's August 2020 briefers was Nikki Floris, the current Intelligence Analyst in Charge at the FBI's Washington Field Office. Floris is a custodian of records responsive to my years-long records request and has not produced any records. Accordingly, I request the DOJ and FBI search classified and unclassified systems for all records, with an initial focus on email communications, referencing Ms. Floris that relate to the August 2020 briefing and produce them to me in unredacted form. This request is in addition to my standing request for all records relating to the briefing including the underlying intelligence basis for it.

Lastly, please produce a September 25, 2020, Intelligence Information Report from FBI's Albany Field Office Serial Number 4212730520 and Sentinel Serial Number 193396452.

I anticipate that your written reply and some responsive documents will be unclassified. Please send all unclassified material directly to me. In keeping with the requirements of Executive Order 13526, if any of the responsive documents do contain classified information, please segregate all unclassified material within the classified documents, provide all unclassified information directly to me, and provide a classified addendum to the Office of Senate Security. Although the Committee complies with all laws and regulations governing the handling of classified information, it is not bound, absent its prior agreement, by any handling restrictions.

If an Intelligence Community agency owns the information that would be responsive to my request, in reply name that agency and the records they've asserted control over to prevent production. Please respond no later than May 19, 2025.
