Dear Mr. Gonzalez:

I write about concerning reports that you are engaged in negotiations with representatives of Venezuela's narco-regime to ease sanctions in exchange for mere assurances that Venezuela will hold a "free and fair" presidential election in 2024. If true, this will be the second time the Biden administration has eased restrictions against Venezuelan human rights violators in exchange for promises they will behave democratically in the future. In November 2022, the administration relaxed oil sanctions against Venezuela as oil prices hit a record high in the United States and President Biden opposed domestic oil production on federal lands. The Biden deal included a prisoner swap exchanging two of Nicolás Maduro's nephews for seven Americans, including five oil executives. If anything, Venezuela's detention of oil executives should indicate the dangers of doing business with narco-terrorists.

As you are no doubt aware, Nicolás Maduro is a fugitive of U.S. justice.<sup>4</sup> Likely emboldened by the Biden administration's previous concessions and the ongoing sanctions negotiations you are leading, Maduro is now reportedly demanding the release of his crony, Alex Saab, an alleged money launderer, in exchange for Eyvin Hernandes and seven other detainees.<sup>5</sup> A U.S. official purportedly told *Reuters* that Mr. Hernandes "was 'quite possibly coerced into

appealing to Biden to swap him and seven other U.S. detainees for Alex Saab[.]"<sup>6</sup> The official claimed the U.S. was not negotiating a prisoner swap. However, just three months later, news outlets reported the arrival of Special Presidential Envoy for Hostage Affairs Roger Carstens in Venezuela.<sup>7</sup>

Despite the Biden administration's inclination to loosen the reins on the Maduro regime, efforts to entice fair elections from narco-terrorists have reportedly failed. <sup>8</sup> Concessions embolden Maduro, further aggravating instability in the country. While the Biden administration recently recognized the unstable circumstances in Venezuela in granting a redesignation of Temporary Protected Status (TPS) for Venezuelans, this administration's policy of appearement to Maduro is counteractively prolonging the very conditions that currently prevent Venezuelans from returning home.

Please arrange a briefing for my staff on the Biden administration's relaxation of sanctions against Venezuela, oil agreements with the Venezuelan government, and prisoner exchanges before October 22, 2023. If you intend to ease restrictions further or release any more of Nicolás Maduro's co-conspirators, please brief my office beforehand, as this strategy appears to have been largely ineffective and dangerous thus far.
