Dear Postmaster General Steiner:

According to legally-protected whistleblower disclosures provided to my office, the United States Postal Service (USPS) hired a registered sex offender as a mail carrier. The whistleblower disclosure noted that the employee disclosed his status as a registered sex offender on his job application. It's been further alleged that instead of firing this individual, USPS placed the individual on administrative leave upon discovering his status. On September 23, 2024, I spoke on the Senate floor highlighting USPS's obstruction of my oversight of this matter. Specifically, USPS refused to provide my staff with a list of mail carriers who are registered sex offenders because, according to the Postal Service, the Privacy Act barred the agency from doing so. Additionally, USPS initially refused to provide a complete list of all USPS letter carriers because my staff might cross-reference them against public sex offender registries.

My staff followed up with USPS and requested a list of USPS employees, including their names, titles, and locations, who self-reported as being sex offenders; the specific legal basis for withholding that information from Congress; and policies related to ongoing review of sex offender registries. On May 12, 2025, USPS responded:

The Postal Inspection Service conducts an annual review of the federal sex offender registry to identify any current Postal Service employees listed as registered offenders. When the Postal Inspection Service identifies a potential employee match, it forwards the data to the appropriate USPS District Human Resource Officer for a determination whether the employee complied with all reporting requirements including disclosure on employment applications if the offense occurred prior to their USPS employment. If an employee is identified and confirmed noncompliant with any reporting requirements, the Postal Inspection Service forwards the matter to the USPS Office of Inspector General for investigation. If the employee is confirmed compliant, the employee is monitored by USPS Human Resources and periodically reviewed by the Postal Inspection Service.

In 2024, the Postal Inspection Service identified 113 registered sex offenders who are employees of USPS. ²

The next day, on May 13, 2025, my staff requested information on the annual "cross-check of a registry list," as well as additional information and personnel records of the 113 identified registered sex offenders who work at USPS. My staff also requested information and records regarding whether USPS tracked the routes of the letter carriers on the sex offender registry, as well as information on whether USPS tracked if employees on the sex offender registry had been accused of any other incident of a "sexual nature." On July 7, 2025, USPS responded to my office. USPS noted:

- USPS does not notify employees when they are working with an individual on the sex offender registry;
- USPS does not have a database that tracks the dates and types of sexual offenses which led to an employee's registration on the sex offender registry;
- USPS does not have a database that tracks whether those employees have been accused of any other incidents of a sexual nature.
- USPS does not maintain a database of the routes that carriers who are registered sex offenders use.⁴

Even more concerning are the numbers of USPS employees who are registered sex offenders that have access to the public. According to USPS's July 7, 2025 response, in 2024, of the USPS's 150 registered sex offender employees – not the 113 as my office was initially told – 102 had jobs that had "access to the public." Of those, in 2024, 77 were part-time or full-time mail carriers. Given these public safety concerns, please answer the following questions:

- 1. Why are registered sex offenders employed by USPS? What legal prohibitions exist that prevent USPS from terminating them?
- 2. Why hasn't USPS removed registered sex offenders from positions where they have access to the public?
- 3. What steps has USPS taken to ensure carriers on the sex offender registry have provided required community notifications?
- 4. What is USPS's process to track whether an employee has become a registered sex offender during their employment? Provide all records.
 - a. Once an employee notifies USPS that they have become a registered sex offender, does USPS terminate that employee? If not, why not?

- 5. What safety mechanisms are in place to protect USPS employees in the workplace from registered sex offenders?
- 6. Of the registered sex offenders currently employed by USPS, how many were registered prior to their employment at USPS? Of those, how many didn't disclose their registration prior to employment? How many registered after their employment at USPS began?

Additionally, please provide a list of names, titles, locations and criminal offense(s) of all current USPS employees who are registered sex offenders.

Question 1:

Please describe the "cross check" process, including, but not limited to, the markers checked to determine a registry match and the steps taken to ensure all matches are identified; the number and job titles of employees who conduct this cross check; whether the cross-check includes all USPS components, including the executive headquarters, Postal Inspection Service employees, and contract employees; and when USPS began conducting the annual registry cross-check. In responding to this request, please include all written protocols for all steps of this process.

The process to check against the DOJ National Sex Offenders Public Website (NSOPW) started in 2011. All postal employees (including executives) are checked. We do not check postal contractors. We do not have access to postal contractor lists.

The first and last names are sent to the NSOPW, and the following is returned:

- First Name
- Last Name (including any alias)
- Middle Name
- Address
- City
- State
- ZIP
- Age

The DOJ application then filters the returned records to make sure the last name (or alias) matches the last name sent to DOJ. A spreadsheet is populated with the above fields from NSOPW, as well as the full name, sex, work position/title, work facility name, city, state and ZIP, home address, city, state, ZIP, age and date of birth (DOB) from the employee database. Then, all entries in the spreadsheet are manually checked against the NSOPW database to determine if there is a match. DOB is the best indicator, but some states do not store DOB information.

There are approximately 18 Postal Inspectors in the field (some divisions have two inspectors) that perform the checks at their respective divisions.

Question 2:

For each year since 2020, by year, identify the number of employees who were found by USPS, including by a District Human Resource Officer, not to have complied with reporting requirements. What is the process the District Human Resource officers are required to follow when an employee is noncompliant, and what audits are conducted to ensure these officers are following the process? Provide all audits for the past five years.

Since 2020, the Inspection Service has evidence of only one employee who was identified as noncompliant with reporting requirements. That was from 2021.

After the Inspection Service notified Human Resources of a registered sex offender employee, Human Resources verifies whether that person has complied with internal reporting requirements and reports its findings back to the Inspection Service. Employees out of compliance with internal reporting requirements are reported by the Inspection Service to the Office of Inspector General (OIG). Field Human Resources Directors supervise the Field Human Resources Managers and are responsible for

ensuring the Managers are cooperating with the Inspection Service. There are no "audits." The Inspection Service can escalate its inquiry to the Director if the Manager is unresponsive for any reason.

Question 3:

Since 2020, by year, how many employees who were identified as noncompliant with any reporting requirement were forwarded to the USPS Office of Inspector General for investigation? Is the Inspector General required to investigate referrals of noncompliant sex offenders? If not, how many cases did the Inspector General accept and decline for investigation?

Since 2020, we have documentation of only one employee who was identified as noncompliant with reporting requirements. The noncompliance was in 2021 and this information was forwarded to the OIG. We are unaware of the outcome of this referral. The OIG is a separate, independent oversight agency. Please contact the OIG to determine their investigation requirements.

Question 4:

What steps does USPS take to notify other employees who work in close proximity with registered offenders?

Due to the restraints of the Privacy Act of 1974, the Postal Service does not notify other employees of whether they work with registered sex offenders. The Privacy Act restricts the Postal Service from disclosing personally identifiable information absent specific consent from the individual or a routine use. Without going through all the routine uses, the only one that would be potentially applicable to fellow employees would be the need to know to perform an official Postal Service job function. People working alongside potential offenders do not have a need to know in order to perform their official Postal Service job functions.

Question 5:

Describe the process by which registered-offender employees are "periodically reviewed," and what is included in this review. Provide the number of these reviews that led to a corrective action for an employee, with a description of the corrective action for each incident.

There is a detailed periodic review of registered sex offenders (RSOs), including required interviews and a criminal history check every three years. The periodic review process includes the same steps undertaken for a newly identified RSO. The registered sex offender program guide/standard operating procedures for Inspection Service personnel details the review process and is included with this response.

The RSO POC at Postal Service Headquarters is unaware of any reviews that have led to corrective action.

Question 6:

Within the past five years, have there been any incidents where any Postal Service employee on the sex offender registry was accused of any other incident of a sexual nature while employed by USPS,

including, but not limited to, sexual assault and sexual harassment? For each instance, if applicable, how did the USPS handle the allegation, and what discipline was provided?

The Postal Service does not have a database that tracks whether employees who are registered sex offenders have been accused of any other incident of a sexual nature.

Question 7:

For all 113 employees identified by the Postal Inspection Service as being registered sex offenders in 2024, and all of those so identified since 2020, by year, please provide the job titles, dates of start and end of employment for each job title, dates and types (e.g. involving children) of the sex offenses that led to the employee's registration requirement, and the dates the employees registered with the sex offender registry. For any mail carriers who were identified as being on the sex offender registry since 2020, how many had carrier routes that brought them within half a mile (2640 ft.) of a school, daycare center, or other facility used primarily for children?

In 2024, 150 employees were identified by the Postal Inspection Service as being registered sex offenders. Attachment included for 2020, 2021, 2022, 2023, and 2024.

The Postal Service does not maintain records of routes by whether they have schools, daycares, or other facilities primarily for children.

The Postal Service does not maintain a database that provides the dates and types of sex offenses that led to an employee's registration requirement or the dates the employee registered with the applicable registry.

Question 8:

For the past five years, by year, how many employees identified as being on the sex offender registry had job duties that involved access to the public, including postal service clerks? Please include the total number of employees, to include those who worked part time or had access to the public for only a short period of time, as well as written plans in place to reduce the risk to the public.

2020: 93

2021: 99

2022: 106

2023: 120

2024: 102

All Postal Service employees are held to the same standards and requirements, and violations of these rules can lead to corrective action, up to and including removal.

Dear Postmaster General Steiner:

According to legally-protected whistleblower disclosures provided to my office, the United States Postal Service (USPS) hired a registered sex offender as a mail carrier. The whistleblower disclosure noted that the employee disclosed his status as a registered sex offender on his job application. It's been further alleged that instead of firing this individual, USPS placed the individual on administrative leave upon discovering his status. On September 23, 2024, I spoke on the Senate floor highlighting USPS's obstruction of my oversight of this matter. Specifically, USPS refused to provide my staff with a list of mail carriers who are registered sex offenders because, according to the Postal Service, the Privacy Act barred the agency from doing so. Additionally, USPS initially refused to provide a complete list of all USPS letter carriers because my staff might cross-reference them against public sex offender registries.

My staff followed up with USPS and requested a list of USPS employees, including their names, titles, and locations, who self-reported as being sex offenders; the specific legal basis for withholding that information from Congress; and policies related to ongoing review of sex offender registries. On May 12, 2025, USPS responded:

The Postal Inspection Service conducts an annual review of the federal sex offender registry to identify any current Postal Service employees listed as registered offenders. When the Postal Inspection Service identifies a potential employee match, it forwards the data to the appropriate USPS District Human Resource Officer for a determination whether the employee complied with all reporting requirements including disclosure on employment applications if the offense occurred prior to their USPS employment. If an employee is identified and confirmed noncompliant with any reporting requirements, the Postal Inspection Service forwards the matter to the USPS Office of Inspector General for investigation. If the employee is confirmed compliant, the employee is monitored by USPS Human Resources and periodically reviewed by the Postal Inspection Service.

In 2024, the Postal Inspection Service identified 113 registered sex offenders who are employees of USPS. ²

The next day, on May 13, 2025, my staff requested information on the annual "cross-check of a registry list," as well as additional information and personnel records of the 113 identified registered sex offenders who work at USPS. My staff also requested information and records regarding whether USPS tracked the routes of the letter carriers on the sex offender registry, as well as information on whether USPS tracked if employees on the sex offender registry had been accused of any other incident of a "sexual nature." On July 7, 2025, USPS responded to my office. USPS noted:

- USPS does not notify employees when they are working with an individual on the sex offender registry;
- USPS does not have a database that tracks the dates and types of sexual offenses which led to an employee's registration on the sex offender registry;
- USPS does not have a database that tracks whether those employees have been accused of any other incidents of a sexual nature.
- USPS does not maintain a database of the routes that carriers who are registered sex offenders use.⁴

Even more concerning are the numbers of USPS employees who are registered sex offenders that have access to the public. According to USPS's July 7, 2025 response, in 2024, of the USPS's 150 registered sex offender employees – not the 113 as my office was initially told – 102 had jobs that had "access to the public." Of those, in 2024, 77 were part-time or full-time mail carriers. Given these public safety concerns, please answer the following questions:

- 1. Why are registered sex offenders employed by USPS? What legal prohibitions exist that prevent USPS from terminating them?
- 2. Why hasn't USPS removed registered sex offenders from positions where they have access to the public?
- 3. What steps has USPS taken to ensure carriers on the sex offender registry have provided required community notifications?
- 4. What is USPS's process to track whether an employee has become a registered sex offender during their employment? Provide all records.
 - a. Once an employee notifies USPS that they have become a registered sex offender, does USPS terminate that employee? If not, why not?

- 5. What safety mechanisms are in place to protect USPS employees in the workplace from registered sex offenders?
- 6. Of the registered sex offenders currently employed by USPS, how many were registered prior to their employment at USPS? Of those, how many didn't disclose their registration prior to employment? How many registered after their employment at USPS began?

Additionally, please provide a list of names, titles, locations and criminal offense(s) of all current USPS employees who are registered sex offenders.

Question 1:

Please describe the "cross check" process, including, but not limited to, the markers checked to determine a registry match and the steps taken to ensure all matches are identified; the number and job titles of employees who conduct this cross check; whether the cross-check includes all USPS components, including the executive headquarters, Postal Inspection Service employees, and contract employees; and when USPS began conducting the annual registry cross-check. In responding to this request, please include all written protocols for all steps of this process.

The process to check against the DOJ National Sex Offenders Public Website (NSOPW) started in 2011. All postal employees (including executives) are checked. We do not check postal contractors. We do not have access to postal contractor lists.

The first and last names are sent to the NSOPW, and the following is returned:

- First Name
- Last Name (including any alias)
- Middle Name
- Address
- City
- State
- ZIP
- Age

The DOJ application then filters the returned records to make sure the last name (or alias) matches the last name sent to DOJ. A spreadsheet is populated with the above fields from NSOPW, as well as the full name, sex, work position/title, work facility name, city, state and ZIP, home address, city, state, ZIP, age and date of birth (DOB) from the employee database. Then, all entries in the spreadsheet are manually checked against the NSOPW database to determine if there is a match. DOB is the best indicator, but some states do not store DOB information.

There are approximately 18 Postal Inspectors in the field (some divisions have two inspectors) that perform the checks at their respective divisions.

Question 2:

For each year since 2020, by year, identify the number of employees who were found by USPS, including by a District Human Resource Officer, not to have complied with reporting requirements. What is the process the District Human Resource officers are required to follow when an employee is noncompliant, and what audits are conducted to ensure these officers are following the process? Provide all audits for the past five years.

Since 2020, the Inspection Service has evidence of only one employee who was identified as noncompliant with reporting requirements. That was from 2021.

After the Inspection Service notified Human Resources of a registered sex offender employee, Human Resources verifies whether that person has complied with internal reporting requirements and reports its findings back to the Inspection Service. Employees out of compliance with internal reporting requirements are reported by the Inspection Service to the Office of Inspector General (OIG). Field Human Resources Directors supervise the Field Human Resources Managers and are responsible for

ensuring the Managers are cooperating with the Inspection Service. There are no "audits." The Inspection Service can escalate its inquiry to the Director if the Manager is unresponsive for any reason.

Question 3:

Since 2020, by year, how many employees who were identified as noncompliant with any reporting requirement were forwarded to the USPS Office of Inspector General for investigation? Is the Inspector General required to investigate referrals of noncompliant sex offenders? If not, how many cases did the Inspector General accept and decline for investigation?

Since 2020, we have documentation of only one employee who was identified as noncompliant with reporting requirements. The noncompliance was in 2021 and this information was forwarded to the OIG. We are unaware of the outcome of this referral. The OIG is a separate, independent oversight agency. Please contact the OIG to determine their investigation requirements.

Question 4:

What steps does USPS take to notify other employees who work in close proximity with registered offenders?

Due to the restraints of the Privacy Act of 1974, the Postal Service does not notify other employees of whether they work with registered sex offenders. The Privacy Act restricts the Postal Service from disclosing personally identifiable information absent specific consent from the individual or a routine use. Without going through all the routine uses, the only one that would be potentially applicable to fellow employees would be the need to know to perform an official Postal Service job function. People working alongside potential offenders do not have a need to know in order to perform their official Postal Service job functions.

Question 5:

Describe the process by which registered-offender employees are "periodically reviewed," and what is included in this review. Provide the number of these reviews that led to a corrective action for an employee, with a description of the corrective action for each incident.

There is a detailed periodic review of registered sex offenders (RSOs), including required interviews and a criminal history check every three years. The periodic review process includes the same steps undertaken for a newly identified RSO. The registered sex offender program guide/standard operating procedures for Inspection Service personnel details the review process and is included with this response.

The RSO POC at Postal Service Headquarters is unaware of any reviews that have led to corrective action.

Question 6:

Within the past five years, have there been any incidents where any Postal Service employee on the sex offender registry was accused of any other incident of a sexual nature while employed by USPS,

including, but not limited to, sexual assault and sexual harassment? For each instance, if applicable, how did the USPS handle the allegation, and what discipline was provided?

The Postal Service does not have a database that tracks whether employees who are registered sex offenders have been accused of any other incident of a sexual nature.

Question 7:

For all 113 employees identified by the Postal Inspection Service as being registered sex offenders in 2024, and all of those so identified since 2020, by year, please provide the job titles, dates of start and end of employment for each job title, dates and types (e.g. involving children) of the sex offenses that led to the employee's registration requirement, and the dates the employees registered with the sex offender registry. For any mail carriers who were identified as being on the sex offender registry since 2020, how many had carrier routes that brought them within half a mile (2640 ft.) of a school, daycare center, or other facility used primarily for children?

In 2024, 150 employees were identified by the Postal Inspection Service as being registered sex offenders. Attachment included for 2020, 2021, 2022, 2023, and 2024.

The Postal Service does not maintain records of routes by whether they have schools, daycares, or other facilities primarily for children.

The Postal Service does not maintain a database that provides the dates and types of sex offenses that led to an employee's registration requirement or the dates the employee registered with the applicable registry.

Question 8:

For the past five years, by year, how many employees identified as being on the sex offender registry had job duties that involved access to the public, including postal service clerks? Please include the total number of employees, to include those who worked part time or had access to the public for only a short period of time, as well as written plans in place to reduce the risk to the public.

2020: 93

2021: 99

2022: 106

2023: 120

2024: 102

All Postal Service employees are held to the same standards and requirements, and violations of these rules can lead to corrective action, up to and including removal.
