With that said, I would like to express from one American to another a sincere thank you for your support and service.

It was the Spring of 2001 when I set my sights on becoming an FBI Special Agent while a student at Montana State University. It was that goal that led me to the Air Force ROTC program, and it was in that cadet lounge that I and my fellow cadets watched in amazement as the World Trade Center fell and the Pentagon burned. Our country went to war; I graduated and secured my commission and went on to serve in uniform for more than four years.
