## *Academy Nomination Guidelines*

Send **COMPLETED** applications to my Des Moines office.

Complete the application form, and other items noted on the enclosed checklist.

Be sure your ACT or SAT scores are sent to me to be included in your file.

**ACT - use code 7129**

**SAT – use code 6260**

\*This must be sent directly from ACT/SAT to my Des Moines office.

Ask **THREE** people to write letters of recommendation to me on your behalf. Please include at least one teacher and two Iowans. Letters should be sealed and signed. These need to be included in your nomination packet.

Give the Evaluation Form to your guidance counselor or principal to be completed, sealed and included in your packet (Note: this person should not be included as one of your recommendation sources).

Complete a typed, one to two page, single spaced essay. Your essay should expand on your interest in applying to a military academy and what makes you a qualified candidate for a nomination. This should be information that cannot otherwise be gathered from the other parts of your nomination application. The essay is used in lieu of an interview.

Sign the media release consent form that is included with the application. My office sends a press release of the names of applicants that I nominate to an academy. Please complete the media consent form and include it in your academy nomination packet to my office. In the event that you receive a nomination, this will ensure your name is included on the press release. If you do not want your name included on a press release, please leave the consent form blank.

Contact the academy or academies you are interested in attending. Open your file by visiting the respective academies website and creating a profile. **I can only nominate students who have applied to the academy directly.** I do not nominate students to the U.S. Coast Guard. Please contact them directly.

Compile ALL required application materials, and mail or deliver in **ONE PACKET** or **ENVELOPE** to my Des Moines office. Submissions submitted via email or fax will not be accepted. I will acknowledge your file when it is complete. If you do not hear from me when you believe your file should be complete, please call my Des Moines office at: 515-288-1145. I will not consider any file unless it is completed and received in-hand by the deadline.

**\*The deadline for completing your file is October 16, 2019. ALL information must be in-hand.** I plan to make the nominations no later than December 31, 2019. You will be notified whether or not you receive a nomination from my office. Please mail applications to the following address:
